



## **Website Privacy Notice**

## **Notice regarding the personal data collected from the PUREEF-Y website.**

We hereby wish to inform you that **CMMI – Cyprus Marine & Maritime Institute (HE396180)** (hereinafter referred to as the **CMMI** or **Company** or **We**) handles your personal Data in a transparent way and in full respect to your rights and personality and in accordance with Regulation 2016/679 (EU) on the protection of natural persons with regards to the processing of personal data and on the free movement of such data (the **Regulation**).

For the purposes of this notice, **personal data** means every information about you that establishes or can establish your identity, for example your name and surname, your telephone number or your city name, or your computer's IP address.

Furthermore, **processing of personal data** means any act or series of acts performed on your personal data, including, inter alia, collection, recording, organization, structuring, storage, data search, use, any way of disposal, erasure, or destruction.

We ask you to read this Privacy Notice carefully as it contains important information about the personal information we collect about you, what we do with your information and who your information might be shared with.

### **3. How do we process your personal data collected through our webpage?**

We store your personal data when you visit our webpage or during your contact with us, through e-mail or submit a form through our newsletter, to be able to respond to your concerned request.

The personal data of our webpage's users is not automatically collected, except in the cases mentioned below.

The personal data we collect through our webpage is used for the improvement of our webpage's user experience, to communicate with you in a timely manner or to provide services for affiliate applications.

**4. How long do we keep your personal data collected from our webpage for?**

The personal data we collect through our webpage is only kept for as long as necessary to fulfill the purpose for which it was collected. Regarding your personal data that we collect from our webpage, you reserve the rights mentioned in paragraph 5.

**5. What are your rights according to the Regulation?**

According to the New General Data Protection Regulation 2016/679 you have the following rights:

- a) **right to access your personal data** (section 15): According to this right you may receive information and/or copies of your personal data that we hold and concerns you free of charge.
- b) **right to rectification** (section 16): According to this right you may ask to correct or complete your data at any time.
- c) **right to erasure (*right to be forgotten*)** (section 17): According to this right you might request from us to erase the personal data that concern you.

However, we reserve the right to deny the erasure, if the processing is necessary for compliance with our legal obligations, for reasons of public interest and/or for the exercise of legal claims.

- d) **right to restriction of processing of your personal data** (section 18): According to this right you might require us to restrict the processing of your personal data if you contest the accuracy of it, the lawfulness of the processing and/or because it is not necessary for the processing purposes they had been collected for
- e) **right to data portability** (section 20): According to this right you can receive the personal information concerning you, in a structured, commonly used and machine-readable format, to transfer it to other organisations/companies or ask us to do so directly to other organisations/companies upon your instruction.
- f) **right to object** (Art. 21 of Regulation): You have the right at any time to object to the processing of your personal data, including profiling, based on the legitimate and/or public interest (section 6 (1) (e) and (f)) when you deem that this is justified due to a particular situation that concerns you.

In case that you do not agree, we shall no longer process your personal data unless it demonstrates compelling legitimate grounds for the processing which override your interests, rights and freedoms or if the processing serves the establishment, exercise or defence of legal claims.

You may object at any time to the processing of your personal data under Article 22 for purposes related to direct marketing or decisions being taken by automated means including profiling which produce legal effects concerning you or similarly significantly affect you, to the extent it concerns direct marketing. In case where we process your personal data for marketing purposes and you object to the said processing, the processing for the said purposes will cease.

- g) **right to withdraw your consent:** You have the right at any time to withdraw your consent to collection and processing of your personal data. In such case, the withdrawal of the consent does not affect the legality of the data processed prior to the revocation.

It is noted that the abovementioned rights apply with the restrictions provided for in the Regulation. ## 6. **What personal data do we automatically collect when you visit our webpage?**

Cookies are small text files, stored on your computer's hard drive, or on your smart phone and do not in any way collect your personal data, such as your name, surname, or your IP address. This webpage uses Session cookies, which are automatically erased from your computer, when you close your internet browser.
